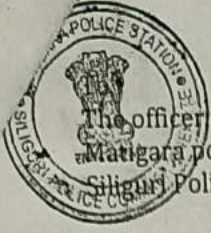


I, SI Krishna Ch. Mandal of Matigara PS SPC to the effect that on 17.01.2022 while performing SPL Mobile duty under Matigara PS area found four persons namely (i) Bijay Roy (30), S/O S ubash Roy of Battala, Champasari, PS-PDN, Dist- DJG, (ii) Dipankar Roy (28), S/O Jagadish Roy of Dabgram-1, PS -BKT, Dist- JPG, (iii) Rana Ghosh (29), S/O Anand Ghosh of Niranjana Nagar, PDN, Dist- DJG, (iv) Apurba Ghosh (30), S/O Deben Ghosh of Santipur, PS- Biswanath, Chakdi Sonitpur, Bihar were loitering near Khaprail More under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt.
