Sir,

In producing herewith one person namely Biswajit Mandol (23yrs) S/O Ranjoy Mandol of Khudirampally Ps., Bagdogra Dist. Darjeeling along with the following articles under seizure viz,

1. 10 (ten) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 600 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",
2. 12 (twelve) bottles of Mc Dowell's XXX Rum (each bottle containing 180 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1",
3. One printed nylon bag.

I, SI Binup Mahato of Bagdogra Police Station, SPC do hereby lodged this written complaint against the above noted arrested person namely Biswajit Mandol (23yrs) S/O Ranjoy Mandol of Khudirampally Ps., Bagdogra Dist, Darjeeling to the effect that on 16.01.2022 at evening around 18.05 hrs in course of special mobile duty vide Bagdogra PS, GDE no 1402 Dtd, 16.01.2022 along with force and as per secret source information I, along with force held raid at Bhujipani area and apprehended the above noted arrested person who is carrying huge quantity of illicit liquor in a nylon printed bag clandestinely and standing at Bhujipani area for selling to his designated customers during the time of pandemic situation in high rate seeing the police party some of customers were flee away to run from the spot. On asking Biswajit Mandol replied that he have no other source for earning. Subsequently the above noted articles were found on his printed nylon bag who, being asked failed to produce any valid documents/papers in support of possessing and selling of the said illicit liquor and further admitted that he is involved in such trade for last few months. Accordingly, I seized the above mentioned liquor recovered on his shop under proper seizure list and labelled and also arrested him u/s 41(A) CrPC issuing memo of arrest. The whole process of seizure and labelled was made in between 18.25 hrs to 19.15 hrs.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Biswajit Mandol (23yrs) S/O Ranjoy Mandol of Khudirampally Ps., Bagdogra Dist. Darjeeling and arrange for its investigation.
