In producing here with the one accused person namely Biswanath Biswas (52) s/o Late Dharendra Nath Biswas of Bidhya Chakra Colony, Ward No. 44, PS Bhaktinagar, Jalpaiguri along with following seized articles as per proper seizure list:


1. Sixteen Bottles of Himalayan Gold Country Spirit 60 UP each Bottle containing 600ml.
2. Two Bottles of Himalayan Fata Fati 70 UP Country Spirit each Bottle containing 300 ml.

I, SI Kamal Kumar Sarkar of Bhaktinagar PS under Siliguri Police Commissionerate lodged this written complaint against the above noted accused person to the effect that on 18.01.2022 at around 18.35 Hrs received a source information that the above noted accused person has stored huge quantity of liquor illegally at his house for the purpose of selling the same to the local customers. Accordingly after informing you I along with force had been to Bidhyachakra Colony under Bhaktinagar PS and held raid at his house and apprehend one person who disclosed his identity as noted above and recovered above noted seized articles from his house. On enquiry the apprehended person admitted his guilt and stated that he has procured the same for selling to local customers without any Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 19.25 hrs to 19.45 hrs. I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.


I, therefore pray before your kind honour that a specific case may be started against the accused person namely Biswanath Biswas s/o Late Dharendra Nath Biswas of Bidhya Chakra Colony, Ward No. 44, PS Bhaktinagar, Jalpaiguri under proper section of law and arrange for its investigation.
