On various occasion I have demanded my Pass Book and Cheque Book but he always neglect my word and did not handover my Pass Book and Cheque Book. At last I went to my Bank and told them to issue new Pass Book and they issue Pass Book on 07/01/2022.

I have carefully gone to my Pass Book account detail where I found on 06.12.2021, Rs. 7,00,000/- (Rupees Seven Lakh) only cheque transfer to Mr. Chandan Sahani, vide cheque No. 295561. I have never sign a cheque of Rs. 7,00,000/- (Rupees Seven Lakh) only which was fraudulently done by my son Mr. Chandan Sahani.

I have verbally informed the Bank about this matter that without verifying my signature how the money has been transferred in Mr. Chandan Sahani's State Bank Of India, Matigara Hat Branch account.


I therefore prays before you to kindly investigate this matter and enable me justice by getting back my hard earn money in my Bank Account and punish those person who are connected with this.
