Sir,

In producing herewith one arrested accused person namely Pradip Dutta (M-32) S/O Late Gour Dutta of Vidya Chakra Colony, Ward No-44, PS Bhakti Nagar, Jalpaiguri along with seized articles (1) 10 (Ten) bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, M.R.P Rs. 120/- each (2) 01 Nylon Bag which used for carrying the seized articles SI no- 1.

I, ASI Binowjit Ghosh of Panitanki TOP under Siliguri PS herby lodge a written complaint against the above noted accused person to the effect that today on 16.01.22 morning at 10:35 hrs during morning mobile van duty I received secret source information that one person is carrying huge quantity of bottle of country spirit through Sevoke road, near M Bazar and proceeded towards Vidya Chakra Colony. Accordingly inform the matter to O.C Panitanki TOP and as per his direction I along with C/1036 Gopal Sribastav and CV/1007 Manoj Roy left for Sevoke road, near M. Bazar to work out the information. On arrival at Sevoke road, near M Bazar, at 10:45 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said persons with loaded articles in presence of witnesses. On interrogation the accused person disclosed his name and address as mentioned above. On demand he failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Vidya Chakra Colony and its adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 10 (Ten) bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each bottles when packed, MRP Rs. 120/- each and (2) 01 (One) Nylon Bag which used for carrying the seized articles SI No- 1, under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 10:55 hrs to 11:05 hrs. Then I arrested the above noted accused person u/s 41 Cr.P.C. after explaining charge against him. Total value of seized articles is Rs. 1200/-

Hence, under the above circumstances I am submitting this written complaint against the above accused person namely Pradip Dutta S/O Late Gour Dutta for starting a specific case under proper section of Law and to arrange for its investigation.
