Thus, they violated the said order and I arrested him/them U/S-41[1][a]Cr.p.c after properly briefing them about the ground of arrest and supplied them the copy of memo arrest accordingly.

Hence, I would therefore request you to kindly start a specific case under section of Law against the above noted accused persons & obliged.
