Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/XVII-ISS/2M-22/2020 dated 15.12.21and order No-753/XVI-ISS/2M-22/2020 dated 02.01.22. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accounding I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.
