The following items have been stolen from our site:-

1. Manhole Cover (6 nos) (Twenty four thousand rupees)
2. Welding machine with cable (1 no) (Twenty two thousand rupees)
3. Electric wire (approx 500 m) (Twenty five thousand rupees)
4. Cast Iron Cube Mould (18 nos) (Ten thousand rupees)
5. Steel (approx 250kg) (Fifteen thousand rupees)
6. Gate valve and fittings (2 nos) (Eight thousand rupees)
