In producing herewith 04 (Four) arrested accused persons U/s 41 Cr.P.C who disclosed their identity as (1) Shiva Sarkar (18 Yrs) S/O-Parimal Sarkar of Barivasha, P.S-NJP, Dist-Jalpaiguri (2) Manaranjan Mandal (55 Yrs) S/O-Late Suman Mandal of Barivasha, P.S-NJP, Dist-Jalpaiguri (3) Narayan Shil (31 Yrs) S/O-Late Dhiran Shil of Barivasha, P.S-NJP, Dist-Jalpaiguri (4) Ram Chowdhury (36 Yrs) S/O-Late Lakhpati Chowdhury of Jabravita, P.S-NJP Dist-Jalpaiguri.

I, SI Gautam Laskar of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that today (15/01/22) in between 17:25 Hrs and 18:15 Hrs in course of performing QRT mobile duty I along with force went to Gate Bazar area, PS- NJP, Jalpaiguri and found (1) Shiva Sarkar (18 Yrs) S/O-Parimal Sarkar of Barivasha, P.S-NJP, Dist-Jalpaiguri (2) Manaranjan Mandal (55 Yrs) S/O-Late Suman Mandal of Barivasha, P.S-NJP, Dist-Jalpaiguri (3) Narayan Shil (31 Yrs) S/O-Late Dhiran Shil of Barivasha, P.S-NJP, Dist-Jalpaiguri (4) Ram Chowdhury (36 Yrs) S/O-Late Lakhpati Chowdhury of Jabravita, P.S-NJP Dist-Jalpaiguri were gathered there without any reason and found them without wearing mask and also making unnecessary gathering at Gate Bazar area area. On interrogation they also stated that they were well aware of Govt. order regarding pandemic situations and wearing of facemasks was mandatory in public places in the current pandemic situation.

They all are violated the order of Govt. of West Bengal vide Memo No 753/XVII-ISS/2M-22/2029 Dtd. 02/01/2022 regarding pandemic situations. Hence, I arrested them under proper memo of arrest in between 17:25 Hrs and 18:15 Hrs and duly signed by them in presence of witnesses and inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
