Gate Bazar Near Ram Thakur Mandir, PS- NJP, Dist- Jalpaiguri, 4] Tapash Barman,(M/25), S/O- Dhaneswar Barman of Shantimoy Colony near Hari Mandir , PO& PS- Matigara, Dist- DJG, 5]Dhruba Sankar Paul (M/39), S/O- Radhika Sankar Paul of Near Milan Pally, near Ram Thakur Mandir , w/No- 31 PS- NJP, Dist- JPG,6] Sanjoy Singh (M/30), S/O- Ashu Singh, of Santoshi Nagar near Khafusa Mandir, W/No- 04, PS- SLG, Dist- SLG. do hereby lodge complaint against the above noted arrested persons to the effect that, on 18.01.2022 at 19.15 hrs during my R/T Mobile Van duty had been to Venus more, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/XVII- ISS/2M-22/2020 Dt.15.12.2021 and order No. 753/XVIII-ISS/2M-22/2020 Dt.02.01.2022. and 753/XX- ISS/2M-22/2020 Dt.15.01.2022 The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I arrested above noted persons u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.


