I, SI Uday Shankar Mandal of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 18.01.22 at about 20:05 hrs while performing evening Special raid duty at Panitanki More and found the above noted arrested persons were moving here and there without using face mask. On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and violating the Govt order. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/XVII-ISS/2M-22/2020 dated 15.12.21 and order No-753/XVI-ISS/2M-22/2020 dated 02.01.22. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.
