With reference to the subject mentioned above, it is inform you that acquisition of
private land measuring 35.93 acres located under Mouza- Bhorat Singh, J.L. No. 102, L.R. Plot No.
340,347,& 348 at village Ranidanga. was done vide Gazette Declaration, Darjeeling No.
151/LA/SSB/01/04/03-04/ dated 02.06.2004.

Out of 35.93 acres of acquired land 1.162 acres is located on outer side of the existing
perimeter boundary wall of SSB campus which is illegally encroached by some local people from last
few years and on dated 17.01.2022 during perimeter patrolling of the campus it was noticed that 02
nos. R.C.C base construction started by local villagers, namely- Monoj Saha (contact No.
9002885270) and Liton Sarkar (contact No. 8101002134) at SSB land.

Since the matter regarding eviction of people from SSB property is already under
process with the BL&LRO, Naxalbari, SDL&LRO, Siliguri and SDO, Siliguri, such illegal construction
may lead to further complications to law and order situation in future.

Therefore, it is requested to make necessary arrangement to stop on-going
unauthorized construction work at SSB land immediately and lodge in complain for the above matter,
please.
