-Sir,

I the above named complainant begs to lodge you this FIR to the
following ground and effects :-

1. That I am the above named complainant and I am complaining against the accused.
2. That I have got a small land and on that land I have made a shop and some remaining vacant portion is also available. I am running this shop since 25 year and still the property is in my possession.
3. That the accused persons have also got a living house behind my shop.
4. That on 10/1/2022 the accused persons together with 7 other persons came to my shop and vacant land and intentionally made a hot altercation by using all means of foul language and threat so that their intention was to capture of my vacant land.
5. That with strong resistance the accused failed in their mission and on 11/1/2022 I have filed a case U/s 144 Crpc against the accused vide Misc Petition case No: 6/2022 and the Ld. Court has made police order to make a strict vigil.
6. That thereafter again on 15/1/2022 at about 3:00 PM the accused with other 7 person came to my land and shop and forcefully tried to capture my property by building some fence and making boundary. As soon as I got this news I immediately went to the spot to obstruct them.

7. That as soon as I reach the spot, the accused No: 1 and 2 was ready with iron rod and others with bamboo sticks. When I came in front to them immediately without any conversation the accused started hitting me with those iron rods and with bamboo sticks.
8. That the accused have hitted me from behind over my head and on my chest as a result I felt down on the ground and some blood also came out from my body. Then all the accused started hitting me with several kicks and blows and I prayed for mercy but all the accused haven't listen my words.
9. That the accused No: 1 and 2 tried to make me more injure by taking out a knife and put it over my neck and threatened me that they will insert the knife over my neck and make me kill and will capture the land with or without any cost. The accused also, took away my golden chain, ring and a cash of Rs 3000/- from me.
10. That I shouted for help and then the local people around me came running and tried to catch the accused person. Seeing this situation the accused with other person went running and I fell on the ground being unconscious position.
11. That the other local person took me to the medical clinic and gave me medicine and first-aid and latter my family members came and took me to my home where I was on rest and was very week due to such violence made by them.
12. That today somewhat I feel better condition and now I came before you to make a complaint against the accused so that the accused person should get punishment as per law.

Under the above circumstances I pray before you to start an investigation against the accused and also to arrest the accused for the acts that they have done to me which I will be grateful to you.
