In producing herewith the arrested 07 (Seven) accused persons namely (1) Sanjoy Nagasia M/21 yrs S/O Anil Nagasia Of Munibusty Chowpukuria PS Bagdogra, Dist- Darjeeling (2) Prasanta Paul M/25 yrs S/O Jayanta Paul Of Medical more Kawakhari , PS Matigara Dist- Darjeeling (3) Tapas Roy M/30yrs S/O Mendu Roy Of Gosai pur,Rupsingh jote PS Bagdogra, Dist- Darjeeling.(4) Abinash singha M/46 yrs,S/O Lt Surendra nath Singha Of Nijbari PO Nijbari PS Phansidewa Dist Darjeeling, (5) Pradhan Singha M/50 yrs,S/O Satyeshwar Singha Of Narayan jote PO Rangapani PS Bagdogra Dist Darjeeling, (6) Tuhin Paul M/22 yrs S/O Thakurdas Paul Of Rngapani Paulpara PS Bagdogra Dist Darjeeling,(7) Bijoy Sarkar M/28 yrs S/O Lt Basu Sarkar Of Kawakhali Near Desun Hospital PS Matigara Dist Darjeeling arrested u/s 41 Cr.PC do hereby lodge a written complaint against him.

In this regard, I beg to state that on 20/01/2022 at about 17.25 hrs. While performing special mobile duty vide GDE No: 795 DT: 20/01/2022, received information that some people are violating the order of Lockdown and roaming aimlessly at Chathat Medical more area, Informed O/C, NBMC OP Under Matigara PS and as per his direction, I along with force had been to Chathat medical More and arrested the above noted accused person. Thereby completely violating the lockdown measures issued by Chief Secretary West Bengal vide order no. 753/XV II-ISS/2M-22/2020 DTD.02/01/2022. On seeing police, they tried to flee away but somehow, the above noted person could be apprehended. On interrogation, they disclosed their name and address as noted above. On further interrogation, they admitted that they were aware of the lockdown Order and Restrictions imposed upon the movement of human being and shops. As he has violated the Lockdown Order promulgate by the appropriate Government Authority and also the provision of Disaster Management Act, 2005, I with the help of force arrested him U/S 41 CrPC by issuing him memo of arrest.

I, therefore pray that a specific case under proper section of law may kindly be initiated against the above noted arrested accused person.
