Sub:F.I.R. against illegally obtaining electric connection
by making fraud, cheating and by making forged
signature of myself and my two brothers namely
Sri Ganesh Paul and Sri Mithun Paul

Sir,

With due honour I Sri Shyamal Paul son of late Gopal Paul resident of Panchanan Sarani, Haidarpara, P.O.Haidarpara P.S. Bhaktinagar, District-Jalpaiguri do hereby lodge this complaint to the effect that my father late Gopal Paul son of late Hari Kanta Paul was the owner and possessor of land measuring 02 kathas appertaining to Khatian No. R.S.741, Plot No. R.S.158, Sheet No. 12, J.L.No. 02, situated within Mouza-Dabgram, Pargana-Baikunthapur, Police Station -Bhaktinagar, District-Jalpaiguri and the land situated at Haidarpara Siliguri by virtue of inheritance. That after the demise of my father my mother Srimati Kanchan Paul, sister namely Pinki Paul and we three brothers namely Sri Shyamal Paul, Sri Ganesh Paul and Sri Mithun Paul his legal heirs became owner of the above mentioned land as a right of inheritance. That my father allowed Sri Goutam Ghosh son of late Gobinda Ghosh as a tenant and provided him a tenanted shop measuring 7x10=70 Square Feet on a monthly rent of Rs. 250/- (Rupees Two Hundred Fifty) only for 05 Five years with effect from 01.10.2004. That the said tenancy ceased/cancelled on 01.10.2009 but he forcibly captured my shop measuring 7x10=70 Square Feet, illegally without paying any rent for the said shop to us.

That my father expired leaving behind his wife namely Srimati Kanchan Paul, a daughter namely Pinki Paul and three sons namely Sri Shyamal Paul, Sri Ganesh Paul and Sri Mithun Paul as his legal heirs. That my mother and my sister donated their share of the land on which the said shop is located, in favour of myself and my two brothers namely Sri Ganesh Paul and Sri Mithun Paul by virtue of gift deed being No.977973 of 2018. That the said land is mutated in the name of myself and my two brothers namely Sri Ganesh Paul and Sri Mithun Paul being Holding No. 257/1935 vide mutation case No. 127/19-20 dated 11.04.2019 and at present myself and my two brothers namely Sri Ganesh Paul and Sri Mithun Paul are the owner of the land on which the said shop measuring 7x10=70 Square Feet is standing.

That on 12.01.2022 I came to know that Srimati Shipra Ghosh wife of late Goutam Ghosh by making fraud, forgery and cheating falsely prepared a No-objection Certificate showing that I along with my two brother have given her No-Objection to take separate Electric Connection in the said shop measuring 7x10=70 Square Feet from the office of the Station Manager CCC, Hakimpara Electric Office, Siliguri .That the said Shipra Ghosh by making forged signature of myself and my two brothers namely Sri Ganesh Paul and Sri Mithun Paul falsely prepared the said No-Objection certificate and by submitting the forged documents before the Station Manager CCC, Hakimpara Electric Office, Siliguri illegally obtained electric connection .That as soon as I came to know about the same I have filed written complaint before the Station Manager CCC, Hakimpara Electric Office against the said Shipra Ghosh wife of late Goutam Ghosh for taking electric connection by making false and forged documents by cheating, fraud and forging the signature of mine and my two brothers namely Sri Ganesh Paul and Mithun Paul.

That in spite of receiving the written complaint against the said Shipra Ghosh wife of late Goutam Ghosh of Haidarpara , P.S. Bhaktinagar , District- Jalpaiguri for disconnecting the electric connection which she obtained by making false and forged documents by cheating, fraud and forging the signature of mine and my two brothers namely Sri Ganesh Paul and Mithun Paul, the Station Manager CCC, Hakimpara Electric Office, Siliguri did not response and asked me to lodge a written complaint before you for proper investigation against the illegal , cheating, fraud and forgery done by the said said Shipra Ghosh wife of late Goutam Ghosh of Haidarpara, P.S.Haidarpara, District-Jalpaiguri.

Under the above circumstances ,I humbly request you to kindly take appropriate action against the above named said Shipra Ghosh wife of late Goutam Ghosh for committing such a heinous offence and also to face the consequences of her such criminal act and so that I shall be highly obliged of you.
