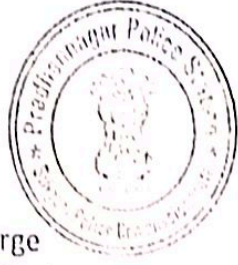

Sir,

In producing here with six arrested accused persons namely namely 1) Dilip Singh (36) s/o Manindra Singh of Cooli Para Ward No 1 PO=Pradhan Nagar, Dist-Darjeeling, 2) Shankar Malakar (32) s/o Lt. Mihir Malakar of Himalayan Residecy PS-Pradhan Nagar, Diat-Darjeeling, 3) Mithu Prasad(36) s/o Santosh Prasad of Siliguri Junction Ward No 1 PO+ PS-Pradhan Nagar Dist-Darjeeling, 4) Rahul(28) s/o Buj Mohan of Moti Lodge, Junction PS-Pradhan Nagar, Dist-Darjeeling, 5) KripaShankar kumar (22) s/o Sri Dagen Choudhury of B.P.O ,Sadananpur, PS-Balia, Dist-Bigusarai, Bihar, 6) Abinash (24) s/o Rakesh Kumar Sharma Patna, PS-Jakkan Pur, Dist-Patna arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 14.01.2022 while performing patrolling van duty received information that some persons were loitering without gathering mask at Darjeeling More area. I along with C/473 Amrita sarkar and C/1086 Goutam Barman had been to Darjeeling More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19.

I, finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 16:45 hrs to 17:25 hrs. On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
