Sir,

In producing here with five arrested accused persons namely 1) Rajesh Thakur (22) s/o Ramji Thakur of Amtala, Chyan Para PO Hyder Para PS Bhaktinagar Dist Jalpaiguri 2) Ananta Das(22) s/o Badal Das of Amtala, Chyan Para PO Hyder Para PS Bhaktinagar Dist Jalpaiguri 3) Sanjib Roy (24) s/o Dilip Roy of of Amtala, Chyan Para PO Hyder Para PS Bhaktinagar Dist Jalpaiguri 4) Sachin Roy (22) s/o Kunjomohan Roy of of Amtala, Chyan Para PO Hyder Para PS Bhaktinagar Dist Jalpaiguri 5) Apu Roy (45) s/o Subir Roy of Samar Nagar, Battala PS Pradhannagar Dist Darjeeling under arrested U/S 41 Cr.P.C and do hereby I SI Rabindra Nath Sarkar lodge a written complaint against them.

In this regard I beg to inform you that on 19.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/476 Jagat Ch Roy and VP 09 Sanjib Kodalia had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 15:10 hrs to 15:45 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
