Sir,

In producing herewith one arrested accused person namely Santosh Haldar (49 yrs), S/O- Samaresh Haldar of 18 no Milanpally, PO- Milanpally, PS- NJP, Dist- Jalpaiguri under arrest along with seized articles viz. (i) 12 (twelve) bottles of Himalayan Gold 60 up Country Sprit, each bottle containing 600 ml. (ii) 03 (three) bottles of Carlsberg Premium Elephant Strong beer each bottle containing 650 ml. (iii) 03 (three) bottles of Budweiser Magnum beer each bottle containing 650 ml. (iv) 04 (four) bottles of Mc Dowell's No 1 Celebration Rum each bottle containing 180 ml. I SI Kamala Sarkar of Milanpally OP under NJP PS do here by lodged a written complaint to the effect that today on 22/01/2022 at 18.15 hrs acting on a tip-off source information myself along with ASI Dipak Singh, C/-881- Bappa Roy, C/445 - Dilip Roy had been to Gajoldoba Teesta Barrage Bazar Canal Road under Milanpally OP in a PS govt. Vehicle to work out the information that a huge number of country sprit are stocked in the shop of one Santosh Haldar (49 yrs), S/O- Lt. Subal Biswas Of 18 no Milanpally, PO- Milanpally, PS- NJP, Dist- Jalpaiguri styled as "Maa Hotel and Lodge" without license to sale the same in the open market. This refers to Milanpally out post GDE No- 568, DT-22/01/2022. On arrival at Gajoldoba Teesta Barrage Bazar at 18.25 hrs and I summoned two local witnesses to witness the raid and on being identified by the engaged source we held raid in the shop of Santosh Haldar styled as "Maa Hotel and Lodge" and could recover the above noted of liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liquors under proper seizure list and arrested the accused person U/S - 41 Cr.P.C and took him into the custody. The seizure was made in between 19.05 hrs to 19.35 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused person namely Santosh Haldar (49 yrs), S/O- Samaresh Haldar of 18 no Milanpally, PO- Milanpally, PS- NJP, Dist- Jalpaiguri.
