With due respect, I am producing herewith the arrested accused persons namely (i) Rajkumar Mandal (26 yrs) S/O late Basanta Mandal of Janatapara, Ward No-35, PS- NJP, Dist.- Jalpaiguri (ii) Raju Das (38 yrs) S/O late Swapan Das of Sepaipara, PS- NJP, Dist.- Jalpaiguri (iii) Nirmal Mandal (23 yrs) S/O Kalachan Mandal of Shanti Para, Near Ekta Sangha, PS- NJP, Dist.- Jalpaiguri and (iv) Sanjoy Saha (21 yrs) S/O late Chaitanya Saha of Shantipara, Near Ekta Sangha, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One iron made sharp cutting weapons called as Hasua from the possession of accused Rajkumar Mandal (26 yrs) S/O late Basanta Mandal of Janatapara, Ward No-35, PS- NJP, Dist.- Jalpaiguri
2. One iron made sharp cutting weapons called as Bhojali from the possession of accused Raju Das (38 yrs) S/O late Swapan Das of Sepaipara, PS- NJP, Dist.- Jalpaiguri.
3. One sharp cutting knife and one torch light from the possession of accused Nirmal Mandal (23 yrs) S/O Kalachan Mandal of Shanti Para, Near Ekta Sangha, PS- NJP, Dist.- Jalpaiguri
4. One sharp cutting knife and one sharp cutting weapon called as Bhojali from the possession of accused Sanjoy Saha (21 yrs) S/O late Chaitanya Saha of Shantipara, Near Ekta Sangha, PS- NJP, Dist.- Jalpaiguri.

I, ASI Khagen Barman of NJP PS, Siliguri Police Commissionerate beg to state that on 23.01.22 at 00.05 hrs myself along with ASI Sajal Das, C/1053 Paresh Rava, HG/794 Ranjit Roy, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy, and CV/824 Niru Yadav left the PS to perform night petrolling duty vide NJP PS GDE No 1025 dated 23.01.2022. During my duty on 23.01.22 at about 01.35 hrs I received a secret source information that a gang of miscreants come at Madani Bazar under PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Madani Bazar area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC about the information in hand. I also informed the fact to night RT Van officer SI Kamalesh Joarder and SI Prabir Raha and requested them to come to Madani Bazar to accompany with us. On 23.01.22 at 02.15 hrs we arrived at near Madani Bazar under PS- NJP, Dist.- Jalpaiguri. After a few time RT Van officer SI Kamalesh Joarder and SI Prabir Raha along with force came to near Madani Bazar and accompany with us. At about 02.35 hrs as indicated by the source we noticed that 09/10 persons assembled in a dark place inside Madani Bazar PS- NJP, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 04 (Four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted.
