Sir,
 With due respect, I am producing herewith one arrested accused person namely Kamal Roy (35 yrs) S/O late Krishna Roy of D.S. Colony, ward No - 35, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 12 (Twelve) bottles of 60 Up Himalayan Gold Country Spirit containing 600 ML in each bottle.
2. 07 (Seven) bottles of 60 Up Himalayan Gold Country Spirit containing 300 ML in each bottle.
3. 04 (Four) bottles of 70 Up Himalayan Fatafati country spirit containing 300 ML in each bottle.
4. 02 (Two) bottles of Kingfisher Strong Premium Beer containing 650 ML in each bottle.

I, ASI Khagen Barman presently attached with NJP PS under your kind control beg to state that today i.e. on 23.01.22 at 18.05 hrs I received a secret source information that one person namely Kamal Roy of D.S. Colony, PS- NJP, Dist.- Jalpaiguri is selling I/D liquor illegally at his hotel styled as Krishna Hotel situated at Netajee More, NJP. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1053 dated 23.01.22 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, VP/08 Laxman Roy and VP/13 Jamirul Islam and others all of NJP PS, SPC left for Netajee More, NJP to work out the information in hand. At about 18.20 hrs we arrived at Netajee More, NJP and being identified by the source I held raid at Krishna Hotel and managed to apprehend the owner of the said hotel. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling I/D liquor at his hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19.05 hrs to 19.55 hrs on 23.01.22.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Kamal Roy (35 yrs) S/O late Krishna Roy of D.S. Colony, ward No - 35, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
