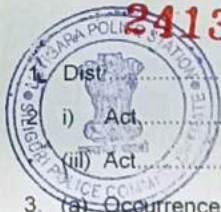

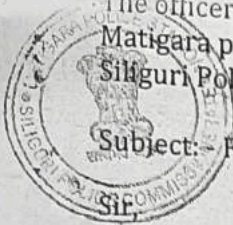

Agarwal of Eastern By pass, PS-BKN, Dist-JPG, (iii) Dipak Barman (27), S/O Bhabesh Barman of New Chumta, PS-MTG, Dist-DJG arrested u/s 41 Cr.P.C.

I, SI Sushanta Dhar of Matigara PS SPC to the effect that on 23.01.2022 while performing SPL Mobile duty under Matigara PS area found three persons namely (i) Ranjan Kumar Dubey (39), S/O Rakhal Chand Dubey of Deoghar, PS-Kunda, Dist- Deoghar, (ii) Harshit Agarwal (24), S/O Anik Kr. Agarwal of Eastern By pass, PS-BKN, Dist-JPG, (iii) Dipak Barman (27), S/O Bhabesh Barman of New Chumta, PS-MTG, Dist-DJG were loitering near Khaprail More under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.753/XV II-ISS/2M 22/2020 Date- 02.01.2022. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Agarwal of Eastern By pass, PS-BKN, Dist-JPG, (iii) Dipak Barman (27), S/O Bhabesh Barman of New Chumta, PS-MTG, Dist-DJG proper section of law and arrange for its investigation.
