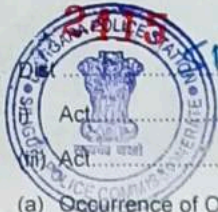

I, SI Kalipada Barman of Matigara PS SPC to the effect that on 23.01.2022 while performing SPL Mobile duty under Matigara PS area found Five persons namely (i) Akash Saha (23), S/O Bikash Saha of Arabinda pally, PS-SLG, Dist-DJG, (ii) Ranjit Sarkar (45), S/O Lt.
