I, SI Kalipada Barman of Matigara PS SPC to the effect that on 24.01.2022 while performing SPL Mobile duty under Matigara PS area found Three persons namely (i) Aman Agarwal (30), S/O Harish Agarwal of Uttorayon, PS-MTG, Dist-DJG, (ii) Rahul Agarwal (23), S/o Suresh Agarwal of Iskon Road, PS- BKN, Dist-JPG, (iii) Jay Prakash Agarwal (55), S/O Lt. 
