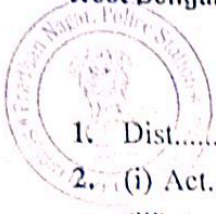

Sir,

In producing here with seven arrested accused persons namely 1) Rakesh Roy (25) s/o Bachhu Roy of Pokaijote, PS Pradhan nagar Dist Darjeeling, 2) Anurodh Sah (25) s/o Laxman Sah of Rajib Nagar PS Pradhan nagar Dist Darjeeling, 3) Jaichand Lakhotia (56) s/o Lt. J L Lakhotia of Mirik Krishna Nagar PS Mirrik, Dist Darjeeling, 4) Kundan Yadav(18) s/o Anil Yadav of Belasamdi, PS Bithan Dist Samastipur (Bihar) 5) Mukesh Poddar (29) s/o Suresh Poddar of near Biswadip Cinema Hall Poddar Lodge PS Pradhan nagar Dist Darjeeling, 6) Vivek Podder (27) s/o Santosh Poddar of near Biswadip Cinema Hall Poddar Lodge PS Pradhan nagar Dist Darjeeling, 7) Bijendra ray (29) s/o Lt. Sankar Deb Roy of Upper Bhanu Nagar PS Bhaktinagar Dist Jalpaiguri under arrested U/S 41 Cr.P.C and do hereby I PSI Kamini Roy lodge a written complaint against them.

In this regard I beg to inform you that on 22.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Darjeeling More. I along with C/543 Purna Rishi and C/ 974 Mintu Sen had been to Darjeeling More and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 18:30 hrs to 19:15 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
