Sir,

In producing here with seven arrested accused persons namely 1) khursed Alam s/o Md. Izharul Haque of Maszid More, Champasari PS Pradhan Nagar Dist Darjeeling, 2) Raja Ghosh (24) s/o Lt. Bikash Ghosh of Gass godown, Darjeeling More PS Pradhan Nagar Dist Darjeeling, 3) Ayush Chettri (21) s/o Gopal Chettri of Mallaguri Tea auction Road, Himalayan apartment ward No 46, PS Pradhan Nagar Dist Darjeeling, 4) Md. Fulkan Alam @ Rakesh (32) s/o Md. Rashid Alam of Ratanlal Busty PS Pradhan Nagar Dist Darjeeling, 5) Souravh gishing (21) s/o Bivash Gishing of medical More, Sushrata Nagar PS Matigara Dist Darjeeling, 6) sanjay Ram (35) s/o Nagendra ram of Bifai Busty Kadamgach PS Pradhan Nagar Dist Darjeeling, 7) Pappu ray (36) s/o Lt. Suraj ray of Siliguri Junction, Railway Station ward No 1, PS Pradhan Nagar Dist Darjeeling, under arrested U/S 41 Cr.P.C and do hereby I SI Khela Murmu lodge a written complaint against them.

In this regard I beg to inform you that on 22.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/473 Amrita Sarkar and CV/ 372 Suman Saha had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 19:10 hrs to 19:45 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and cooperate restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
