Respected Sir,

With due respect I, **SRI GOUTAM LAMA**, Son of Late Chandra Bahadur Lama, resident of Ambadhura Salbari, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, would like to inform you that I am the owner of a land measuring about 76 decimal under Khatian No. - 33 corresponding to Plot No.-309, Mouza – Panchonoi, J.L. No.-27, P.S. Pradhan Nagar, within the District of Darjeeling (W.B.). I have filed a civil suit bearing Title Suit No. 167/2015 in Court of the Ld. Civil Judge Junior Division at Siliguri in respect of such land measuring about 76 decimals. The Ld. Court has been pleased to pass an order of injunction to maintain status quo in regard to possession, nature and character of the suit property in respect of the said land measuring 76 decimals. On 21/01/2022, Bishnu Sahani, S/O- Balchand Sahani and one Joy Gopal Mondal, both are resident of Methibari, under your Police Station, have illegally started making construction in and over some portion of the said land. They have erected a bamboo fence covering some area with sole motive to capture my land forcefully. On the same day I went to resist them but they abused me by filthy language. They called me 'chhota jaat' as I am a tribal person. They hit me by fist and blows and lastly

they snatched my wallet wherein I kept Rs. 5000/- (Five Thousand Rupees). I asked them to return my wallet but they took away the same. At the time of leaving they threatened me not to visit my land and if I again would visit, they will murder me. I am now helpless. Furthermore their attempts to capture my land should be stopped immediately.

Therefore I request you to investigate into the matter and to take proper steps and thereby I shall be obliged to you.
