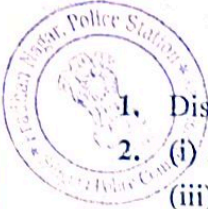

1) That on 22/01/2022 at about 8:30 PM, My elder son namely Md. Nazrul, aged about 22 years, was going towards Jhokar along with his friends namely - Debbrughan Ram, Ajay Das, Shyam Yadav and Krishna Mahato on foot for some work and when they crossed the main gate of Deidede, suddenly Md. Nazrul was dash by a motor bike being registration no. - WD74BB/1136 (Dominar D 400) which was coming from Jhokar side in a very high speed and my son sustained serious/grievous injuries and the rider of the said bike fled away from the spot

2) That the accident occurred due to the negligence of the rider of the motor bike who was riding/plying in a very high speed in a negligent way.

3) That Md. Nazrul was taken to the North Bengal Medical College in and Hospital where the doctor declared Nazrul death.

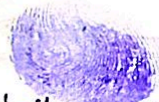
