Sir,

In producing here with six arrested accused persons namely 1)Ajoy Mahato (19) S/O-Harindav Mahato of Dhavam nagar Cooriepara ward no-1,PS-Pradhan nagar Dist-Darjeeling. 2) Rishav Singh (20) S/O- Bikram Singh of Baghajatin Colony PS.Pradhannagar Dist-Darjeeling. 3) Sudhir Kr. Thakur(32) S/O-Shyam Nandan Thakur of Utpal Nagar Champasari PS.Pradhannagar Dist Darjeeling.4)Anitash Anand Jha (34) S/O-Ramanand Jha of Lavapur Narayan,PO-DO,PS- Manar,Dist-Vaishali ( Bihar ) 5.Arjun Kumar (18) S/O-Raju Sahani of Santosh Nagar, PS-Bhaktinagar Dist-Jalpaiguri, 6. Suresh Poddar of Siliguri Junction, RailwayStation Wardno-1,PS.Pradhannagar Dist Darjeeling, under arrested U/S 41 Cr.P.C and do hereby I SI Atanu Majumder lodge a written complaint against them.

In this regard I beg to inform you that on 23.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/830 Pradip Ch Roy and C/999 Mithu Ch. Roy had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 18:10 hrs to 18:45 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful
