With due respect and humble submission, in producing herewith one arrested accused namely Goutam Sarki(32) S/o Lt. Basant Sarki of Kadamtala Kali Mandir, Cjhampasari PS-Pradhan Nagar Dist Darjeeling under arrest along with following seized articles under proper seizure;

- i) **10(Ten) bottles of Himalayan Gold country Spirit 60*up each bottle contains @ 600 ml each.**
- ii) **09(Nine) bottles of Officer'S Choice Whisky each bottle contains 180 ml.**

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 23.01.2022 when I along with CV/223 Swapan Chettri, CV/992 Jagadish Biswas was performing Special Drive duty vide PDN PS GDE NO 1263 dtd 23.01.2022. I received an information that one person namely Goutam Sarki(32) S/o Lt. Basant Sarki has storage huge quantity of illegal liquor in his house at Kalimandir under Pradhannagar PS, Dist Darjeeling and selling the same from his house. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid at his house and detained the above noted person and on search recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 18:35 hrs to 19:10 hrs and I arrested him after maintaining all formalities regarding arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Goutam Sarki(32) S/o Lt. Basant Sarki of Kadamtala Kali Mandir, Champasari PS-Pradhan Nagar Dist Darjeeling and arrange for its investigation.
