Sir,

With due respect and humble submission, in producing herewith one accused namely Kumar Thapa (65) s/o Lt. Tek Beer Thapa of SNT Siliguri junction P.S-Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure :

- i) 08(Eight) Plastic bottles of Himalayan Gold , Country Spirit ,60 up, each bottle containing 600 ML.
- ii) 05(five) bottles of Kingfisher Strong Beer each bottles contains 650 ML.

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 24.01.22 vide PDN PS GDE NO 1311 dtd. 24.01.22 while I was performing Special Drive duty at Siliguri Junction area with CV/645 Pankaj Gupta, CV/223 Swapan Chhetri , at 15.15 hrs I received an information that one person namely Kumar Thapa has storage huge quantity of illegal liquor in his Hotel styles as " Gurung Restaurant" at SNT Siliguri Junction under Pradhannagar PS and selling the same in his Hotel. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the said Hotel and detained the hotel of owner noted above and on being search his hotel recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 15.50 hrs to 16.40 hrs and I arrested him after all formalities.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Kumar Thapa (65) s/o Lt. Tek Beer Thapa of SNT Siliguri junction P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
