Sir,

In producing here with five arrested accused persons namely 1) Akhtar Alam (22) s/o Tafaluddin of Bishahar PS Raiganj Dist-Uttar Dinajpur, 2) Sallendar Sing (30) s/o Muktar Singh of Gurung Busty Ward No 03, PS Pradhannagar Dist Darjeeling 3) Rohit Kr. Sahi (30) s/o Umesh Ch Sahi of Gurung Busty Ward No 03, PS Pradhannagar Dist Darjeeling, 4) Susanta Chakraborty (33) s/o Subesh Chakraborty of Bagajatin Colony , PS Pradhannagar Dist Darjeeling, 5) Bikash Sharma (30) s/o Golab Ch. Sharma of Gurung Busty Ward No 03, PS Pradhannagar Dist Darjeeling under arrested U/S 41 Cr.P.C and do hereby I SI khela Murmu lodge a written complaint against them.

In this regard I beg to inform you that on 24.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Siliguri Junction area. I along with C/473 Amrita Sarkar and CV/ 372 Suman Saha had been to Siliguri Junction area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 - 01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 17.25 hrs to 18:05 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
