I, SMT. MUNNI DEVI AGARWAL, wife of Sri Ashok Kumar Agarwal, resident of Nehru Road, Khalpara, Siliguri, P.O. and P.S. - Siliguri, District - Darjeeling, PIN - 734005, would like to inform you the facts as stated herein under.

That I am the sole, absolute, exclusive and recorded owner in possession of all that piece or parcel of land measuring 0.08 Acres or 5 Kathas comprised in R.S. Plot No.3 corresponding to L.R. Plot No.18, recorded in R.S. Khatian No.2/56 corresponding to L.R. Khatian No.2553, situated within Mouza - Thiknikata, J.L. No.74, Pargana - Patharghata, P.S. - Matigara, District - Darjeeling, having permanent, heritable and transferable right, title and interest therein, and have been regularly paying the required taxes and revenue to the appropriate authority with regard to the said land.

That this is to inform you that today, some workers under the instruction of my son - Sri Gopal Agarwal were undertaking certain maintenance and repair work with respect to the said land and its boundary wall. That surprisingly, during the ongoing maintenance and repair work, abovenamed Chandan Roy, Jhantu Das and their men and associates **approached my said land and threatened the said workers to immediately leave the site of face dire consequences.** That fearing for their lives, said workers immediately left the site.

That the said miscreants thereafter confronted my son and demanded a hefty sum of Rs. 2,00,000/-. My son was strictly ordered that if any maintenance or repair work is to be undertaken, the said miscreants need to be paid immediately failing which they will resort to unlawful extortion and if necessary, take the recourse of unlawful grabbing of the said land.

Sir, me and my son are trembled with terror due to the said unlawful activities of abovenamed Chandan Roy, Jhantu Das and their men and associates. You are hereby requested to register this instant complaint and take strict measures at the earliest in the interest of justice.
