In producing herewith 08 (eight) arrested accused persons who disclosed their name & identity as identity (i) Ajit Kumar Saha (54yrs) S/O- Lt Adhir Chandra Saha of South Colony Bazar, Jamruvita, PS-NJP, Dist-Jalapiguri (ii) Md Alimuddin (39yrs) S/O- Lt Abdul Sattar of Baghagach, PS-Chopra, Dist-Uttar Dinajpur (iii) Shiba Sahani (25yrs) S/O- Lt Tuntun Sahani of Milton Para, PS-Kaliaganj, Dist-U/DNJ (iv) Sanjay Kamti (41yrs) S/O- Ram Abatar Kamti of South Colony, ROH, PS-NJP, Dist-JPG (v) Ashim Paul (53yrs) S/O-Lt Bidhu Bhusan Paul of Suryasen Colony, Block-A, Ward No- 34, Balmiki School, PS-NJP, Dist-JPG (vi) Dipak Dey (52yrs) S/O- Lt Jatish Chandra Dey of Ambikanagar, near RAF IRB Batallion, PS-NJP, Dist-JPG (vii) Prabir Kr Kedia (37yrs) S/O- Indra Chand Kedia of Traders, MR Compound, near Nayabazar, Khalpara, Ward No-9, PS-Siliguri, Dist-DJG do hereby lodge complaint against the above noted arrested persons to the effect that, on 23.01.2022 at 19.05 hrs during my R/T Mobile Van duty had been to Court more, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/XVII-ISS/2M-22/2020 Dt.15.12.2021 and order No. 753/XVIII-ISS/2M-22/2020 Dt.02.01.2022. and 753/XX-ISS/2M-22/2020 Dt.15.01.2022 The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I arrested above noted persons u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
