I, SI Subhendu Das presently posted at Khalpara TOP under your kind disposal producing here with the arrested accused persons namely 1) Safinoor Mandal (30/M) S/O Idrish Mandal of Amtala, PS- Bijnupur, Dist- D/24 Paragana, 2) Bablu Molla (40/M) S/O Jonab Molla of Amtala, PS- Bijnupur, Dist- D/24 Paragana, 3) Pramod Kumar Sah (25/M) S/ORam Sah of Jyoti nagar, Ward No. 04, PS- Siliguri, Dist- Darjeeling, 4) Ebrahim Miya (27/M) S/O Ajad Miya of Adarsha Nagar, Ward No- 04, PS- Siliguri, Dist- Darjeeling, 5) Abhishek Basfore (23/M) S/O Ganesh Basfore of Rangamati, PS- Malbazar, Dist- Jalpaiguri, 6) Pawan Kumar Gupta S/O Gopal Gupta of Sahelihat, PS- Malbazar, Dist- Jalpaiguri, 7) Raju Mahato (22/M) S/O Ramjit Mahato of Rajaholi, Ward No.35, PS- New Jalpaiguri, Dist- Jalpaiguri and 8) Md. I do hereby lodge this written complaint against the above noted arrested accused persons pertaining to the effect that on 24/01/2022 in between 19.30 hrs to 21.25 hrs in course of special mobile duty Vide Khalpara TOP GDE NO. 650 date. 24/01/22 in an around Khalpara TOP under Siliguri Ps area at Jalpaimore in order to restrict the unnecessary movement of the general people without mask for combating the spread of COVOID- 19 vide State government order No 753/XVI- ISS/2M-22/2020 dated 15/12/2021, found the above noted accused persons were moving on the main road at Jalpaimore under Khalpara TOP PS. Siliguri, Dist Darjeeling without any valid reason and taking any precautionary measures for combating the spread of COVID-19, as the order has already been promulgated in Siliguri Municipal Corporation area in order to combating the spread of COVOID-19. Thus, they violated the said order and I arrested him/them U/S-41[1][a] Cr.P.C after properly briefing them about the ground of arrest and supplied them the copy of memo arrest accordingly.

Hence, I would therefore request you to kindly start a specific case under section of Law against the above noted accused persons & obliged.
