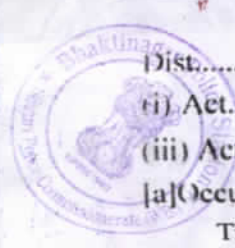

In producing herewith 08 (Eight) arrested accused persons namely (1) Sanjit Saha (40) S/O Lt. Khitish Saha of Lower Bhanu Nagar, PS Bhaktinagar, Dist. Jalpaiguri, (2) Shankar Saha (37) S/O Umapada Saha of Durga Nagar, Arbindo Road, PS Bhaktinagar, Dist. Jalpaiguri, (3) Amar Gupta (38) S/O Mahendra Prasad Gupta of Upper Bhanu Nagar, PS Bhaktinagar, Dist. Jalpaiguri, (4) Raju Singh (39) S/O Bhola Singh of Paresh Nagar, PS Bhaktinagar, Dist. Jalpaiguri, (5) Dipankar Sarkar (33) S/O Fanindra Nath Sarkar of Paresh Nagar, Samir Roy Sarani, PS Bhaktinagar, Dist. Jalpaiguri, (6) Md. Israel (45) S/O Lt. Md. Dhalai of Ashraf Nagar, PS Bhaktinagar, Dist. Jalpaiguri, (7) Umesh Mahato (39) S/O Amarjeet Mahato of Lower Bhanu Nagar, PS Bhaktinagar, Dist. Jalpaiguri and (8) Buddha Rai (32) S/O Lt. Ganesh Rai of Paresh Nagar, near PHE Office, PS Bhaktinagar, Dist. Jalpaiguri arrested u/s 41 Cr.P.C along with the following seized articles viz :

1. Fifty Two (52) pieces of playing cards of different colours.
2. One Old Telegraph Newspaper.
3. Fifteen Thousand and Fifty Rupees Only (15050/-) as a Board Money in different denominations as per seizure list.

I, SI Sailesh Subba of Bhaktinagar PS, SPC do hereby lodged this written complaint against the above noted accused persons to the effect that on 25.01.2022 at around 22.05 Hrs received a source information that the above noted accused persons were gambling with playing cards causing wrongful gain and wrongful loss at the House of Mala Sau at Mini Market, Paresh Nagar under Bhaktinagar PS. This refers to Bhaktinagar PS GDE no. 1442, Dated. 25.01.2022. Accordingly after informing you I along with force had been to Mini Market, Paresh Nagar and held raid at the House of Mala Sau and found the above noted accused persons were gambling with playing cards causing wrongful gain and wrongful loss to each other. After seeing the police team they tried to flee from the spot but I alongwith Police team managed to apprehend all of them and searched properly and recovered 52 pieces of playing cards and board money Rupees 15050/- (Fifteen Thousand and Fifty Rupees Only). On being asked they failed to produce any valid documents for gambling at the aforesaid house. On interrogation the apprehended accused persons admitted that they had assembled at the aforesaid house for gambling with playing cards for their wrongful gain or loss without any valid documents. I therefore, seized the above noted articles and board money under proper seizer list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 22.45 Hrs to 23.05 Hrs and arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrest duly signed by them. I accordingly brought the arrested accused persons along with seized articles at Bhaktinagar P.S for further investigation.

Hence, I pray before you that a specific case may kindly be registered under proper section of law against the above noted arrested accused persons and arrange for its investigation.
