Thereby completely violating the lockdown measures issued by Chief Secretary West Bengal vide order no. 753/XV II-ISS/2M-22/2020 DTD.02/01/2022. On seeing police, they tried to flee away but somehow, the above noted person could be apprehended. On interrogation, they disclosed their name and address as noted above.
