Sir,

With due respect, I am producing herewith one arrested accused person namely Dilip Sarkar (46 years) S/O Late Niranjana Sarkar of Surya Sen Colony, Block-C, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 12 (Twelve) bottles of 60 Up Himalayan Gold Country Spirit containing 600 ML in each bottle.
2. 09 (Nine) bottles of 60 Up Himalayan Gold Country Spirit containing 300 ML in each bottle.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 16.01.22 at 18.05 hrs I received a secret source information that one person namely Dilip Sarkar of Surya Sen Colony, Block-C, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally in his hotel at near 70 More, NJP for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 736 dated 16.01.22 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, ASI Sajal Das, CV/824 Niru Kr Yadav and CV/116 Rohit Kr Mahato and others all of NJP PS, SPC left for 70 More, NJP to work out the information in hand. At about 18.35 hrs we arrived near 70 More, NJP and being identified by the source I held rald at the hotel of the above noted accused and managed to apprehended the owner of the said hotel. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19.05 hrs 19.45 hrs on 16.01.22.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Dilip Sarkar (46 years) S/O Late Niranjana Sarkar of Surya Sen Colony, Block-C, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
