Sir,

I SI Sushanta Dhar of Matigara P.S, SPC do hereby lodge a Complaint to the effect that on 28.01.2022 at 15:00 hrs I received information from my reliable source that some illegal digging going at Tarabari Ghat by JCB. On receiving the information, I informed to O/C Matigara PS and as per kind order of O/C Matigara I along with other forces of Matigara PS rush to the spot to work out the information. On arrival at Tarabari Ghat found one vehicle JCB bearing Reg. No. WB-73 E/9569 is digging river bed materials from Tarabari Ghat and the same was supplied to another vehicle for transporting illegally. On seeing Police team the driver of the JCB tried to fled away, but somehow we managed to apprehend the driver. On interrogation he disclosed his identity as Dilip Singha (26), S/O Kolen Singha of Bijlimony, Ghosh Pukur, PO- Sahabad, PS-Phansidewa, Dist- Darjeeling and confessed that he was digging river bed materials illegally for his illegal motive. As such I seized the above noted loaded vehicle under proper seizure list in presence of available witnesses and arrested him under proper memo of arrest and brought to the above noted vehicle at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the seized vehicle JCB bearing Reg. No. WB-73 E/9569 under proper section of law and arrange for its investigation.
