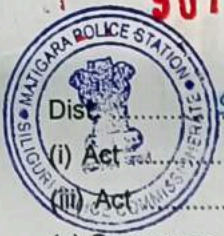

I, SI Susanta Dhar of Matigara PS SPC to the effect that on 30.01.2022 while performing SPL Mobile duty under Matigara PS area found Four persons namely (i) Jugal Mahanto (30), S/O Gossai Mohanta of Shivmandir, PS-MTG, Dist-DJG, (ii) Rohadul Ansari (22), S/O Lt.
