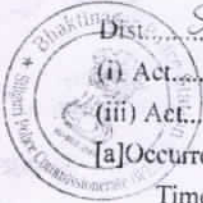

Thus they violated the said order and I arrested them U/S 41 (1) (a) Cr.P.C after properly briefing them about their ground of arrest.


