Sir,

With due respect, I beg to report that, I ASI Bikash Roy presently posted at Siliguri PS, under Siliguri police Commissionerate, beg to state that on 06.06.2021 at 10.20 hrs received a written information from Ward Master of Siliguri District hospital to the effect, on-06.06.2021 at 06.40 am one patient named Biseswar Barman (50 yrs) S/O- Lt. Dhoda Barman of 157, Jamaldaha, Purba Kamat, Changrabandha, PS- Mekhliganj, Dist- Cooch Behar was brought at Siliguri District Hospital where attending Doctor Kanchan Kundu Poddar, after close observation, declared that the said patient was brought dead. Over this information, started Siliguri PS U/D Case no- 208/21 Dated-06.06.2021 and as per endorsement of I/C Siliguri PS, I ASI Bikash Roy took up its investigation.

Accordingly, I along with C/1186 Alphonse Minj of Siliguri PS had been to Siliguri District Hospital and as per identified by the Doctors, Hospital Staffs and relatives of the deceased, I found the dead body were lying at Hospital Morgue. During preliminary enquiry, I came to learnt from relatives of the deceased that on 06.06.2021 at early morning they found the dead body were lying on a drain located at Roy Colony, near Manakamana flour mill under Bhaktinagar PS jurisdiction, and said dead body brought by Sri Somaru Roy of Panchanan Colony, PS- Bhaktinagar Dist- Jalpaiguri. Accordingly, I prepared inquest report over the dead body of the above noted deceased and after completion the same I sent the dead body of the deceased to F.M & Toxicology Department, North Bengal Medical College & Hospital along with all relevant papers and proper police escort by U/D constable 1186 Alphonse Minz for holding post mortem examination to ascertain actual cause of death of the deceased.

On 29.01.2022 I received the Post Mortem report of the above noted deceased person vide P.M No- 1063/21 dated 06.06.2021 from the department of F.M & Toxicology, NBMC & Hospital, where Dr. Rumi Maitra, Demonstrator opened that "Death was due to the effect of asphyxia, as a result of compression of neck, ante-mortem and homicidal in nature".

Under these circumstances, I pray before you that kindly lodge a specific case in this regards and arrange for its investigation as per proper section of law.
