Sir,

In producing here with five arrested accused persons namely 1) Subash Mahato(32) s/oLt. Jagannath Mahato of Santoshi Nagar Silliguri, Ps-Silliguri Dist Darjeeling, 2) Girjesh Kumar (29) s/o Haarakhid Sharma of Mofasid Balapury PS Mofasid Dist Begusarai Bihar 3)Haradhan Karmakar (30) s/o Lt. Bimal Karmakar of 2no Pati Colony Road PS Pradhannagar Dist Darjeeling 4)Pragyan Rai (26) s/o Sukraj Rai of Gumba Gaon PS Kurseong Dist Darjeeling 5) Istarul Khan (32) s/o Lt. Kabul Khan of New Pokaijote PS Pradhannagar Dist Darjeeling under arrested U/S 41 Cr.P.C and do hereby I PSI Kamini Roy lodge a written complaint against them.

In this regard I beg to inform you that on 27.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/1086 Goutam Barman and CV/49 Pancha Singh had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41 Cr PC in between 16.05 hrs to 16.45 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
