Dear Sir,

I would like to inform you that I put an ad on OLX app for home rent.
So, yesterday at evening a man named Sanjay Singh called on my dad's mobile number. He said he is speaking from Lucknow and will shift in Siliguri for his job in Indian Army. He called from 7548940397, this number in my father's no. 9641146529. He asked to send the photos of the flat ^{from} my father's what's app no. So I send all the photos in his number. Later he called & said that he will show the photos to his wife & will confirm by next morning.

At morning 9:24 am he called my father & confirmed to take the flat. He said he will send the security deposit amount 30,000 for 2 months in my netbanking number. He then said first he will send rupees 1 in my account to check whether it gets credited or not. He said check your account balance and see after I send 1 rupee that it got deposited or not. Then he said in call that sister I will send you the money through QR scan. I got 1 rupee deposited in my account. Then he said now I will be sending you 30,000. He send me another QR scan in which it was written above Amount send rupees 30,000. I scanned it & my 30,000. He said the QR scan I send is for few seconds so you should be fast. He said money has not gone to your account so repeat it. By this way I send 3 times 30,000 which is 90,000 from my SBI account. He then said no it didn't get debited so try with your other account, again 30,000 from my account got credited to him through bank of Baroda. So, by that time I got my debit messages, & realised that he is saying lie. He took total amount of 120000 from both my accounts. I started crying & told him that he took all my money. He said no I didn't get any money sister. He said believe me trust me I am taking pledge of Indian army if any money got debited, you will get that back just listen to what I say. He later called me and said believe me I will send you all the money, send me your IFSC code and account no. but I didn't send him any other details. He also send the ID proofs of Sanjay Singh named in Indian army which was all fake now I realised. Also he threatened me of informing to Crime Branch who will arrest me in one hour. I send told him to send the police because I didn't do any crime I have my proof. Then I ended the call.
