i am writing this complaint to seek your assistance to recover my abducted Escort Powertrac Euro tractor no. WB 73/F0733 with chasis no. T053419975JG from Mr. Kokil Barman and his son Mr. Rupkumar Barman, resident of Dumrigurir Chhat, PO. New Rangia, Dist. Darjeeling.

Sir, I purchased my aforementioned tractor on loan from Mahindra and Mahindra Finance dated 18.03.2019 with contract no. 6081687 with agreement value of Rs. 971750 (Rupees Nine lakks seventy one thousand and seven hundred fifty). Being a housewife, I didn't able to properly put the aforesaid tractor in some work and later decided to enter into the deed of agreement for sale of vehicle (attached herewith) dated 15th October 2019 with Mr. Kokil Barman.

Mr. Kokil Barman paid me Rs. 100000 (Rupees One lakh only) and agreed to pay remaining subsequent loan EMIs (Rs.16480 each month) to the financer according to clause 2 of the agreement. But after getting the tractor Mr. Kokil Barman despite regular reminders and calls from the owner overlooked the agreement and started irregular payments of EMIs surpassing the due date of loan repayment (5th of every month) every month which in turn attracted the late charges and interests, violating the clause 2 and clause 10 of the agreement.

Further continuing the above trend Mr. Kokil Barman took advantage of the moratorium on loan repayment for complete 6 months of Rs.98880 (Rupees Ninety eight thousand and eight hundred and eighty) last year and didn't paid a penny to the financer. After that period he again started irregular officer in Chartelent of loan EMI missing the dates and attracting fines and charges. The reluctance of payment of outstanding dues on and before due date from Mr. Kokil Barman also surmounted the delay interest to with overdue payments. Each time I contacted Mr. Kokil Barman or his son Mr. Rupkumar Barman for loan repayment they misbehaved with me or uttered bad words. Each time they ignore me intentionally. They even behaved rudely with my aged father and said they will neither repay any loan amount or hand over the aforementioned tractor to me.

Afterwards, I filed an FIR against them at Bagdogra Police Station (Case No. 361/21) and my tractor was recovered from Mr. Kokil Barman and handed over to me via court order dated 03/08/2021 (attached herewith).

From the date of above incident I have minimized the due amount with regular payment of EMI each month from july'2021 onwards.

Sir, despite above all incident, again on 30th January 2022, morning 8 AM, Mr. Kokil Barman and his son Mr. Rup Kumar Barman forcibly abducted my tractor from the hands of my driver near Tarabari, Balason River, Matigara and called my aged father from mobile no. 7699238187 demanding ransom money and withdrawal of the Court case ( Case No. 361/21, GR-No. 3382/21) against them and threatening to damage the tractor if not done.

Sir, with such threatening calls and such incident me and my family are frightened even to go outside of our home.
