I, SI Prasang Tamang of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that today (18/01/22) in between 18:15 Hrs and 18:50 Hrs in course of performing special mobile duty I along with force went to Netaji More area ,PS- NJP , Jalpaiguri and found (1)Swapan Sarkar (35) S/o- Lt. Madan Sarkar of More Bazar P.S - NJP, Dist- Jalpaiguri (2) Akshya Sinha (27) S/o- Lt. Sanjay Kr. Sinha of North Colony Qtr no- 84/A P.S.- NJP, Dist- Jalpaiguri (3) Azijul Mia (37) S/o- Md. Mia of More Bazar P.S.- NJP, Dist- Jalpaiguri (4) Gopal Das (21) S/o- Lt. Gokul Das of Majha Bari P.s. BKN ,Dist- Jalpaiguri (5) Pritam Das (19) S/o- Prabhu Das of Kanchanbari, P.S.- NJP Dist- Jalpaiguri, (6) Gopal Roy (18) S/o- Kartik Roy of 2no Pamchanan Colony P.S. Pradhan Nagar Dist- Darjeeling(7) Mangal Roy (19) S/o- Mukul Roy of 2no Pamchanan Colony P.S. Pradhan Nagar Dist- Darjeeling (8) Arjun Singh (23) S/o- Lt. Bhat Kanta Singh of Laldas jote P.S. Phansidewa Dist- Darjeeling (9) Swapan Ghosh (40) S/o- Lt. Bimal Ghosh of More Bazar P.S.- NJP Dist- Jalpaiguri were gathered there without any reason and found them without wearing mask and also making unnecessary gathering at Netaji More area. On interrogation they also stated that they were well aware of Govt. order regarding pandemic situations and wearing of facemasks was mandatory in public places in the current pandemic situation.

They all are violated the order of Govt. of West Bengal vide Memo No 753/XVII-ISS/2M-22/2029 Dtd. 02/01/2022 regarding pandemic situations.. Hence, I arrested them under proper memo of arrest in between 18:15 Hrs and 18:50 Hrs and duly signed by them in presence of witnesses and inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
