I Smt. Ragini Goyal, wife of Sri Deepak Agarwal, presently residing at F/1, Amrit Kunj Apartment Jyotinagar, behind Reliance Trends, 2Mile, Sevoke Road, PO Siliguri & P.S. Baktinagar, 734001, District. Jalpaiguri, would like to state that I am the legally wedded wife of Sri Deepak Agarwal, son of Late Om Prakash Agarwal resident of 227/2, AJC Bose Road, Mangal Jyoti Building, Flat No. 201, near Minto Park, Kolkata -20. Our marriage was solemnized on 2-7-2009 at Hyatt Residency Kolkata. Our marriage was an arranged marriage. After the marriage my husband brought me at his residential flat i.e. my matrimonial home situated at 227/2, AJC Bose Road, Mangal Jyoti Building, Flat No. 201, near Minto Park, Kolkata -20 and we started living at the said address as husband and wife after our marriage. From the wedlock of myself with my husband Deepak Agarwal a male child Aarav Agarwal was born on 24-7-2010.

At the time of marriage as per the demand of my husband and his parents, my father paid a sum of Rs. 15,00,000/- (Rupees Fifteen Lacs only) as dowry and my father also gave gold ornaments as gifts to the family members of my husband. The marriage ceremony was a plush affair as per the demand of my husband wherein my father had to incur an additional expense of Rs. 25,00,000/- (Rupees Twenty Five Lacs only) towards marriage expenses.

At the time of my marriage I was a working lady but due to pressure from my husband I had to leave my job and thus I became a housewife. From the very beginning of my marriage, my husband started torturing me mentally and physically on very minor issues and that torture kept on increasing day by day which I tolerated with a hope that he would rectify himself in near future. Be it mentioned here that during the course of his physical torture he would mercilessly beat me up and would bite me and once on 31-3-2019 due to the physical beating and biting, I had to be treated at Belle Vue Clinic, Kolkata. The matter to reported to Ballygunge Police Station which was registered vide GD Entry No - 2882 dated 31-3-2019.

On 3-12-2019 my husband Deepak Agarwal with intention to injure me seriously had pushed me from the back from the staircase because of which I fell down and sustained severe head injury. I have tolerated all the tortures of my husband for the future of my child and with a hope of happy matrimonial life I have sacrificed my all desires and to make my husband happy I left my job and started leading my life upon the instructions and signs and mercy of my husband inspite of that he could never been satisfied.

On 23-2-2021 my husband came to Siliguri to take me back to Kolkata. Due to severe Covid pandemic conditions in Kolkata fearing for the safety of my son, I requested my husband that

I along with my son would come back to Kolkata after few days. He not only assaulted me at my parental house but he dragged me out of the house holding my hairs and ultimately I had no option but to follow him to Kolkata. In the month of May 2021, I was infected with Corona and I was treated in Kolkata. Be it mention here that he totally abandoned me and my near relatives in Kolkata took care of me and paid for my treatment.

On 22-1-2022 my husband again mercilessly assaulted me with fists and blows at my matrimonial home at Kolkata and had throttled my minor son to kill him but I somehow I managed to save my son and myself and took shelter in the house of my maternal aunty at Salt Lake Kolkata and on 23-1-2022 I left Kolkata and on 24-01-2022 I came back to Siliguri, at my parental house.

After my arrival at my parental house I hoped that he would call me and ask me to return back but to my utter surprise I was informed on 27.01.2022 that my husband by forging my signatures had transferred my purchased shares of Eastern Financiers without my knowledge and consent for his illegal gain and wrongful loss to me. On 29-1-2022 he also by forging my signatures had withdrawn a sum of Rs 68,000/- (Rupees Sixty Eight Thousand only) from my personal bank account with Indian bank, Sarat Bose Road Branch, Kolkata.

Sir, yesterday i.e., 31.01.2022 at around 6 p.m. my husband called me at my mobile no. 9339193625 and threatened me that he is coming to Siliguri on 01.01.2022 and that as I had left Kolkata without his permission, he would teach me a lesson and would take away my son Aarav Agarwal forcefully from my custody to Kolkata.

Sir, I am gravely scared for the safety of son and myself and request you to take necessary legal steps against my husband and oblige.
