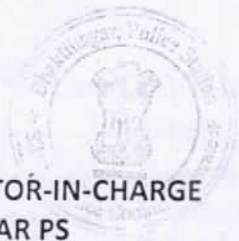

Sir,

In producing herewith one accused person namely Manoj De -36yrs s/o Lt Rabi De of Jyotinagar Near Gulmohar Apartment, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 11 (Eleven) no's of pet Bottles of Himalayan Gold 60up country sprit (each bottle containing 600 ML)
2. Five bottles of Tuborg Premium Beer each bottle containing 750 ML
3. One bottle of Imperial Blue classic Grain whisky containing 750 ML which was packed in one big nylon bag.

I beg to report that I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Manoj De, to the effect that on 01.02.22 at 15.20 hrs received a source information from Jyotinagar under Bhaktinagar PS that one person namely Manoj Dey has gathered huge quantity of liquor in his house at Jyotinagar under Bhaktinagar PS for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-34 dated 01.02.22. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 16.05 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 16.35hrs to 17.40 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Manoj De -36yrs s/o Lt Rabi De, of Jyotinagar Near Gulmohar Apartment, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
