of Ashighar OP lodged a written complaint against the accused person namely I SI Pradip Kr Singha Kartick Choudhury(18), S/O- Dilip Choudhury of Pakurtola more Fakdaibari PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Pakurtola more Fakdaibari area as indicated by my source I held raid at the house Kartick Choudhury at Pakurtola more Fakdaibari.But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 19.25 hrs and 19.45 hrs on 01.02.2022.
