under Milanpally OP. On being asked the above noted persons stated before me that they were well
aware of West Bengal Govt. Order regarding pandemic situation of COVID 19 and new COVID 19 variant
Chennai and wearing of facial mask has been mandatory in public places in the current pandemic
disaster situation.


They violated the West Bengal Govt Order No - 751/XVII - ISS/2M 22/2020, Dated - 02/01/22
hence I arrested them U/S - 41 Cr.P.C. in/w the case under proper memo of arrest duly signed by them

Now I request you for starting a specific case U/S 188/269/270 IPC r/w Sec 51(b) of Disaster
Management Act 2005 against the above noted accused persons and arrange proper investigation of the
