I, ASI Pradip Kumar Sarkar of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that today (27/01/22) in between 17:15 Hrs and 17:55 Hrs in course of performing evening QRT mobile duty I along with force went Gate Bazar area ,PS- NJP, Jalpaiguri and found (1) Vivekananda Roy (21yrs) S/o. Khagendra Nath Roy of Bhabanipur, PS. Kaliaganj, Dist-Uttar Dinajpur (2) Pintu Roy (34 yrs) S/o. Kaben Ch. Roy of Laxmijote, PS. NJP, Dist-Jalpaiguri (3) Biswajit Biswas (326 yrs) S/o. Late Shanti Charan Biswas, of Jorepokhri More, PS. NJP, Dist-Jalpaiguri (4) Pradip Biswas (21yrs), S/o Kartik Biswas of Surya Sen Colony, PS. NJP, Dist-Jalpaiguri (5) Parotosh Roy (22 yrs), S/o. Asaru Roy of Rangalivita, PS. NJP, Dist-Jalpaiguri were gathered there without any reason and found them without wearing mask and also making unnecessary gathering at Gate Bazar area. Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
